### **Agenda Items 1 - 3**

Both LWF and ILC declare an intention to maintain coherence and provide for an exchange of information regarding with discussions dialog partners both may share.

The LWF and ILC discussed the situation of the 11 churches, which hold dual membership in both organizations in a spirit of clarification and understanding. Both the LWF and ILC encouraged these churches to see themselves as a bridge of understanding between these organizations. Future meetings will continue to reflect on dual membership.

The LWF debriefed the ILC on the ongoing Emmaus Conversation. The LWF shared with the ILC the document, "Claiming the Gift of Communion in a Fragmented World," and referred to the LWF council discussions in June 2013 dealing with issues of communion relations, in particular where they are strained due to different theological interpretations.

The LWF and ILC explained to each other the processes, contexts, and background regarding situations where there is not current agreement.

The LWF and ILC discussed areas where conflict emerged and how future conflict might be addressed in a way that is mutually respectful.

In the meeting, the LWF and ILC engaged in theological discussions regarding their respective positions and agreed that future theological discussion could be beneficial.

### **Agenda Item 4**

Rev. David Mahsman, Executive Director of the International Lutheran Society of Wittenberg (ILSW), a non-profit corporation established by the LCMS, SELK, and Concordia Publishing House, gave a Power Point Presentation on the status of the Wittenberg Project and the renovation of the Old Latin School.

### **Agenda Item 5**

The LWF and ILC agreed to continue to share plans for 2017 Reformation Commemoration, and to consider the possibility of some joint action.

### **Agenda Item 6**

The ILC responded with a letter to the LWF invitation to participate in the Mennonite Action.

### **Agenda Item 7**

Both the LWF and ILC thanked one another and appreciated the frank conversation and transparency shown in the discussion. Both agreed that the conversation was valuable and looks forward to the next opportunity to gather. A desire was expressed to meet annually. The LWF will host the next meeting in Geneva on January 14, 2015.

### **Agenda Item 8**

The meeting concluded with Rev. Hans Kasch's and Rev. David Mahsman's presentations on "My experience in Wittenberg from the LWF / the ILC perspective."
